### **Key Objectives:**

To provide a practical technician service to members of staff in the Science Department through the preparation and provision of equipment, apparatus and chemicals to enable students to carry out practical science lessons.

### **Role Responsibilities**

- Daily support of teaching and learning.
- Assisting teachers with demonstrations and experiments.
- Preparing equipment and materials for practical lessons.
- Setting out and clearing away equipment and materials.
- Preparing, filing and retrieving worksheets.
- Shopping for petty cash items.
- Managing the conservation of stock levels to ensure the adequate supply of materials for lessons.
- Demonstrating and advising staff and students on the safe use of equipment and chemicals.
- To provide technical support for ICT in Science in class, and to assist in its development and integration into teaching programmes.

- To liaise with the IT Technician to evaluate, familiarise oneself with and install new software and demonstrate its use.
- To liaise with the IT technician over the installation of new hardware and software within the department.
- To assist in entering data into departmental records.
- Assisting with the development of new technical initiatives.
- Under the direction of the Subject Leader, undertaking development work, relating to improving the efficiency and effectiveness of science laboratories and curriculum resources.
- To ensure continued professional development of practical knowledge, skills and technical expertise.

### **Safety**

- Managing risk assessments (in liaison with teaching staff) on all substances in schemes of work to ensure the safety of science practicals.
- Managing the specialist procedures designed within the current Health and Safety guidelines to ensure the safe operation of laboratories, storage, labelling and disposal of chemicals, radioactive substances and microbiological cultures.

### **General**

- Monitoring and reporting missing or damaged resources.
- Making, repairing and maintaining equipment.
- Responsibility as delegated by the Subject Leader – Science for assessing requirements, requisitioning equipment, materials, chemicals, stationery, liaising with company representatives and the maintenance of appropriate records.
